Index Universal Life Products

Freedom Global IUL II and Freedom Index Universal Life II. Excess Index Interest on the Index Accounts is determined on a one year point-to-point basis based on the percentage change in certain external indexes. The Excess Index Interest is adjusted for the 1% guaranteed rate, and it cannot exceed the Cap established in advance by the Company. The current interest rate on the Basic Interest Account will be declared from time to time by the Company, and it is guaranteed to be at least 2%.

Annuity Products

TransFreedom II: A deferred fixed annuity only available for sales to new participants in an Internal Revenue Code Section 412(e)(3) defined benefit plan that is in existence with Transamerica as of December 31, 2010. The guaranteed minimum interest rate is 1.00%.

TransFreedom II NY: A deferred fixed annuity, issued by Transamerica Financial Life Insurance Company, is only available for sales in New York to new participants in an Internal Revenue Code Section 412(e)(3) defined benefit plan that is in existence with Transamerica as of December 31, 2010. For policies issued October 1, 2011 through September 30, 2012, the guaranteed minimum interest rate is equal to the minimum non-forfeiture interest rate of 1.00%.
